110 total calls last month. Transports were down by 1/3, around 73. The accrediting agency for WVFD's paramedic school is in its final review. Chief Smith has already been contacted by fire districts wanting to enroll students. WVFD received a \$20,000 grant from Yavapai Prescott Indian Tribe to support the Paramedic school program. \$10,000 came from gaming distributions and the other \$10,000 from the tribe as they felt it was an important program. Engineer Academy is underway. It is seven weeks long and attendees will receive several state certifications. Minimum wage increases by 50 cents in January. The Arizona Wildfire Academy is in March at ERAU. Yavapai County BOS provided scholarships for about 7-12 students from our organizations.

Wildland assignments are winding down. Mayer truck is back from California, med team assigned near Flagstaff returned two days ago and Crown King truck will be home tomorrow. Four people were recently hired to fill open spots and vacancies, three from Reserves and one from CAFMA. Suzanne had hip replacement surgery and is rehabbing nicely. Nancy is retiring in December. Hiring/badge pinning ceremony will be held in the next couple of months. The Christmas party is December 9 at Plaza Bowl. Chief Smith will discuss acquiring a water tender with the WV board next Monday. To sell MFD's old water tender, it will need to be declared surplus property by the Mayer board. He explained the JPA process. It was noted, the local union does support a JPA between the two districts.
